



LIMITED LIFETIME WARRANTY

IRONCRAFT® FENCE PRODUCTS

Origin Point Brands warrants its Ironcraft® fence products to be free from defects in material and workmanship for the lifetime of the original purchaser under normal use and service from the date of purchase, subject to the terms and conditions set forth below (the "Express Warranty").



1. WARRANTY COVERAGE

Origin Point Brands' sole responsibility under this Express Warranty shall be, at its option, to either repair or replace any product that fails during the warranty period, provided that the Buyer has promptly reported the claim in writing to Origin Point Brands and complies with the provisions of this Express Warranty.



2. EXCLUSIONS

This Express Warranty does not cover, and Origin Point Brands is not responsible for, any defect or damage caused by transportation, storage, improper installation, maintenance, internal or external hostile environment, misuse, abuse, negligence, accident, modification, tampering, the attachment of any unauthorized accessory, alteration to the product, or any other conditions whatsoever that do not constitute a defect in material and workmanship.



3. DISCLAIMER OF WARRANTIES

EXCEPT FOR THE EXPRESS WARRANTY DESCRIBED HEREIN, ORIGIN POINT BRANDS SPECIFICALLY DISCLAIMS AND EXCLUDES ANY AND ALL EXPRESS AND IMPLIED WARRANTIES WITH REGARD TO ITS PRODUCTS, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR USE, AND FITNESS FOR A PARTICULAR PURPOSE; ALL IMPLIED WARRANTIES ARISING FROM TRADE USAGE, COURSE OF DEALING, COURSE OF PERFORMANCE OR ANY OTHER IMPLIED WARRANTIES. THE EXPRESS WARRANTY STATED HEREIN IS IN LIEU OF ALL OBLIGATIONS OR LIABILITIES ON THE PART OF ORIGIN POINT BRANDS FOR DAMAGES, INCLUDING BUT NOT LIMITED TO, INCIDENTAL OR CONSEQUENTIAL DAMAGES, ARISING OUT OF OR IN CONNECTION WITH THE USE OR PERFORMANCE OF THE PRODUCTS PURCHASED BY BUYER.



4. LIMITATION OF LIABILITY

NEITHER ORIGIN POINT BRANDS NOR ITS AFFILIATED COMPANIES SHALL BE LIABLE TO BUYER IN CONTRACT OR IN TORT (INCLUDING NEGLIGENCE) FOR DAMAGE TO OR LOSS OF OTHER PROPERTY OR EQUIPMENT, LOSS OF PROFITS, REVENUE OR GOOD WILL, LOSS OF USE OF EQUIPMENT, FACILITY OR DATA, EXPENSES INVOLVING COSTS OF CAPITAL, COST OF PURCHASED OR REPLACEMENT POWER OR TEMPORARY EQUIPMENT (INCLUDING ADDITIONAL EXPENSES INCURRED IN USING EXISTING FACILITIES), CLAIMS OF CUSTOMERS, EMPLOYEES OR ANY OTHER PERSONS AFFILIATED, ASSOCIATED OR IN PRIVITY WITH BUYER, OR FOR ANY SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES BY REASON OF BREACH OF THE EXPRESS WARRANTY STATED HEREIN.



5. REMEDIES

The remedies of Buyer set forth herein are exclusive with respect to breach of the Express Warranty stated herein, and the total liability of Origin Point Brands for breach of said Express Warranty, and/or as a result of the manufacture, sale, delivery, installation or technical direction of installation, repair or use of any products furnished to Buyer, whether in contract or in tort (including negligence), shall not exceed the purchase price of the products determined by Origin Point Brands to be defective in material and/or workmanship.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state. Some states do not allow the exclusion or limitation of incidental or consequential damages, or limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you.

This warranty applies only to products purchased and installed in the United States and Canada.

This warranty is non-transferable and extends only to the original end-user purchaser.

Proof of purchase is required.

This warranty is governed by the laws of the State of South Carolina.
